# North Kern Water Storage District Minutes of the Meeting of July 16, 2019

A Meeting of the Board of Directors of North Kern Water Storage District was held at the District Office, 33380 Cawelo Avenue starting at 7:00 a.m., on July 16, 2019.

President Andrew declared a quorum was present and called the meeting to order. The following Directors were present: Kevin Andrew, Carole Fornoff, Joel Ackerknecht, Winn Glende and Mike Mendes. Others present: Richard Diamond (General Manager), Marinelle Duarosan (Controller), Heather Williams (Operations Superintendent), Christy Castaneda (Administrative Assistant) and Erica Celedon (Accounting Clerk) of North Kern Water Storage District, Scott Kuney (District Counsel), Ron Eid and Larry Rodriguez (GEI – Consulting Engineers). Guests included: Dana Munn (Watermaster), Preston Britain (Pacific Resources) and Timothy Gobler (Wonderful).

President Andrew called the meeting to order at 7:00 a.m. and opened the floor for public comments, at this time there were none.

- Watermaster Mr. Munn reported that the Isabella remediation Phase II project construction and blasting continues.

The Corps of Engineers continues to provide small tours of the Isabella project. These tours are going to take place approximately once a month.

The Contract for conservation storage in Lake Isabella is with the Bureau of Reclamation (USBR) not the Corp of Engineers. USBR has the signed contracts and resolutions. North Kern and Buena Vista WSD legal counsel are working on the necessary court validation action and posted a public notice in the Bakersfield Californian on June 22.

The current B120 median forecast predicts 197% April – July runoff. The inflow peaked at 6,701 CFS on June 14 and Isabella storage peaked at 349,447 acft on June 27.

Operations Report – Operations Superintendent Williams reported on District operations stating that the District's share of Isabella storage is estimated at 72,000 AF. Kern River natural inflow and outflow are averaging 2,800 cfs and 3,400 cfs, respectively.

The District Kern River demand is 785 cfs.

CRC produced water of 14 cfs has been diverted to the 9-2 spreading pond in anticipation of a possible spreading operation to Poso Creek. Califia Farms continues to pump into the Lerdo Canal.

## Consulting District Engineer – Consulting District Engineer Ron Eid reported:

- A. High-Speed Rail Authority: Mr. Eid stated HSR activity was limited to review of the 60% design drawings and specs for the 9-22 canal conflict. GEI will work on the preparation of the reimbursement requests to California Rail Builders.
- B. Poso Creek RWMG: Mr. Eid stated there was a public meeting this month. Work on the Plan update continues. DWR had a workshop at the end of June in preparation for submittal of grant proposals for Prop 1 late this summer. There will be a presentation of a group of six projects on behalf of regional water management group this will be discussed later on the agenda.

## C. Grants for Projects:

The District was awarded an amount of \$750,000 for construction of replacement wells and additional well connections to the Friant–Kern Canal. Environmental work has been moving forward and archeological surveys are also completed to support this award. The Bureau continues working on drafting a contract for this award.

We also previously received notice that the District was awarded an amount of \$75,000 to fund the SCADA software and Land IQ ET improvements. The Bureau continues working on drafting a contract for this award.

The 2019 NKWSD Return Capacity Improvements for the WaterSMART Project for drought responses and drought resiliency grant was not awarded to the District.

D. Water Delivery Improvements: The one bid received for the Well Instrumentation project was previously rejected and changes have been made to the specifications and the project will be rebid in late August to solicit more competition.

He further stated GEI is hoping to have an internal administrative draft of the Umbrella GSP to the KGA by the end of July. They are also looking into compiling the entire document which will include the Umbrella GSP and Chapters for public review by the August 28, 2019 KGA Board Meeting.
