Pursuant to District's Rules and Regulations, the undersigned, being all of the owners of the above-described real property, hereby makes application to receive Class 2 water service at the toll set from time to time by the District. Availability of Class 2 lands for water service occurs in years or times when the full water needs of Class 1 lands have been satisfied, but is an interruptible supply. Such water made available will be used by the Water User on twenty-four (24) hour basis and paid for on the basis of monthly billings.

Payment is due on the first day of the month following delivery and delinquent 30 days thereafter. Under Water Storage District Law, such toll charges, when delinquent, must be increased by a penalty of 10%, the resulting total to bear interest at the rate of 12% per year from the date of delinquency until date of payment. No further water will be delivered to a user whose account is delinquent.

Water user, jointly and severally, consents to all charges and collection thereof in the manner set forth in Sections 47181 to 47185, inclusive of the Water Code of the state of California, the "Rules and Regulations" of the district, as the same may be amended from time to time, are incorporated herein by this reference. The undersigned agrees to abide by the terms thereof, including any amendments hereafter to be made.

APPOINTMENT OF AGENT TO ACT FOR WATER USER

(Rules, Section IV. 3)

To the Board of Directors:

The undersigned, being the current water User under that certain **“Application For Water Service” (Exhibit A, B-1 or B-2)** on file with the District affecting the property described herein and being all of the current owners of the land described herein, and each of them, for the purpose of complying with the Rules and Regulations of the District and to be assured of continued regular water service to the lands affected by said Application (agrees with the other and DOES HEREBY APPOINT:

This person is appointed as sole General Agent with full power in (his/her) name and on behalf of Water User, and each and every one of them, to do any act which may be done by Water User Pursuant to said Rules and Regulations including but not limited to full power and authority to make any election that can be made by Water User pursuant there to accepting the assignment or transfer of rights to water service to lands other than those herein described.

Said District is hereby authorized to treat any act done by or to said agent, or any subagent appointed pursuant hereto, as an act of Water User under Rules and Regulations, without further notice to the undersigned Water User, or any of them, as to any matter within Agent’s authority mentioned herein, including but not limited to any or all of the following matters arising from said Rules and Regulations, namely: Giving or receiving all notices, presenting billings, placing water order and making designations and lessee authorization forms, provided in rule, Section IV. 4.

Agent shall have full power and authority to appoint such subagent as he deems necessary to carry out the terms hereof. Such appointment shall be in writing in such form as District may approve, and be acknowledged. Any subagent’s appointment shall terminate by

its terms at the end of each water year unless otherwise provided. Any such appointment may be terminated by Agent by giving written notice to the District executed in the same manner as the appointment.

Each Water User agrees with the other and represents to the District that this agency is irrevocable except as provided in said Rules and Regulations. The power and authority of such agent shall continue until a majority of Water users, determined on an acreage basis, shall, by writing in the form hereof, elect another such Agent and shall furnish District with such appointment executed and acknowledged or in the event of sale or partitioning of the lands herein described, until such time as the District has been furnished with good and sufficient evidence that the Water User no longer owns the land affected by said Contract in undivided ownership. Each of them further understands that this agency will terminate upon the death of the agent, his renunciation or incapacity to act as Agent.

Each Water User agrees with the other and represents to the District that neither the death, nor subsequent incapacity to contract, of an undersigned Water User shall terminate this agency.

The provisions hereof shall be binding upon and shall inure to the benefits of Water User, their respective heirs, executors, administrators, successors and assigns, and each and every one of them, or any person or entity claiming any interest in the lands herein described by, through or under any undersigned water User and to the District and its successors and assigns.
